The Bertie County Board of Commissioners met for a regularly scheduled meeting today at 6:00PM inside the Commissioners Room, 106 Dundee Street, Windsor, NC. CALL TO ORDER

Chairman Trent called the meeting to order.

INVOCATION & PLEDGE OF ALLEGIANCE

Commissioner Ron Roberson gave the Invocation and led the Pledge of Allegiance.

REPORTS & APPOINTMENTS

1. Bertie County Community Collaborative Presentation by Marcia Watford

System of Care Coordinator with Trillium Health Resources Hope Eley stood before the Board to provide them with a brief history of System of Care. She stated to the Board that the Bertie Collaborative currently meets at the Health Department at 1:30 PM on the second Tuesday of every month. She then introduced the Board Chair Marcia Watford.

Board Chair Marcia Watford stated to the Board that they wanted to introduce the Bertie Collaborative and ask the Board of Commissioners for their support in spreading the word in the communities to let the citizens know that the County does have a Collaborative. She invited everyone in the community to come out and see what services that the Collaborative has to offer, and then explained the resources and services that are provided by the Collaborative.

2. 2022 General Election Update by LaToya Peele, Bertie County Elections Director

Elections Director LaToya Peele came before the Board to provide and update on the 2022 General Elections. She informed the Commissioners that Elections season started for them on September 9th, and provided the Board with important dates and deadlines for the upcoming elections.

Thursday, October 20 th	One-stop in-person early voting begins.
Tuesday, November 1 st	Absentee ballot request deadline.
Saturday, November 5 th	In-person early voting and registration ends at 3:00 PM.
Tuesday, November 8 th	General Election Day
Friday, November 18 th	County Canvass Day.
Tuesday, November 29 th	State Canvass Day.

She also informed the Commissioners that sample ballots are available for the citizens.

1. Approve Resolution for Operation Green Light for Veterans

Commissioner Roberson made the **MOTION** to **APPROVE** the Resolution for Operation Green Light for Veterans. The **MOTION** was **SECONDED** by Commissioner Lee. The **MOTION PASSED** with a unanimous decision.

2. CRAVE Project Funding for Courtroom Cabling for Remote Proceedings

Chairman Trent stated that the CRAVE Project Funding for Courtroom Cabling for Remote Proceedings has been **TABLED**, as there was other information on its way to them and the County Manager will receive that information and hopefully have it available for the next meeting which will be on October 17th.

3. Project Amendment

County Manager Vaughan stated that this Project Amendment was in reference to the Opioid Funds that the County had received, and if the Commissioner's had any questions about the Project Amendment, Finance Officer William Roberson was available to explain.

Commissioner Trent asked if they had received a better explanation on how those funds could be used.

Mr. Vaughan stated that there were some upcoming meetings to help them to identify or come up with ways that the funds could be used, and that all they knew at this moment was that the funds had to be used for fighting the opioid addiction crisis.

Commissioner Lee stated that the NCACC also had help available if the County needed assistance with the spending of the funds.

Commissioner Lee made the **MOTION** to **APPROVE** the Project Amendment. The **MOTION** was **SECONDED** by Commissioner Roberson. The **MOTION PASSED** with a unanimous decision.

She had the opportunity to call Mr. Vic Thompson today and thank him, and then publicly thanked the Assistant County Manager David Scarborough for all of the work that he has done for this project.

She thanked everyone for keeping her in their prayers.

Commissioner Trent

Commissioner Trent stated that a lot of the thank you for the Long Branch project needs to go to Commissioner Lee. She was the big push on having the Long Branch project done and it was a lot of work done on her part and she did a great job.

Commissioner Atkins

Commissioner Atkins did not have anything to report.

Commissioner Wesson

Commissioner Wesson welcomed Commissioner Lee back and stated that everyone was delighted to have her back. He thanked Commissioner Lee's husband Vernon for taking such good care of her.

He stated last week they had received a \$100,000 grant for the Teacher Housing project. He shared that they have already received the check from the Department of Education who has also promised additional support in the implementation of making the Teacher Housing project a reality.

He noted that Senator Bazemore was instrumental in helping the County to receive those funds.
