The Bertie County Board of Elections held their monthly meeting on Tuesday, January 30, 2024 at 210 W. Watson Street, Windsor, NC.

The meeting was called to order by Chairman Wm. Michael Freeman. Mr. James Lee gave the Invocation.

Business

Appointment of Precinct Early Voting Officials

The first order of business was the Appointment of Early Voting Precinct Officials. Mrs. Staneski made a motion to appoint the Early Voting Precinct Officials for the Board of Elections Office and Powellsville Town Hall. Mr. Lee Second the Motion.

Early Voting Officials Oath of Office

Chair Freeman stated the appointed Early Voting Precinct Officials will take their Oath of office during Early Voting Training.

Unaffiliated Candidate: John Trent

Director Peele informed the Board that County Commissioner John Trent filed his petition request on January 19th to appear as an Unaffiliated Candidate on the General Election Ballot. Director Peele informed the Board that Commissioner Trent has to receive 4% of the total number of Registered Voters as of January 1st (12,563). Director Peele further stated that the total number of required petition signatures is 503 and the deadline to return the signatures is Tuesday, March 5th at 12:00 pm.

Machine Testing and Mock Election

Director Peele informed the Board that she was in the process of performing Logistic and Accuracy Testing on the DS200 Machines to prepare them for the upcoming election. Director Peele also informed the Board that the State Mock Election is Thursday, February 1st.

Early Voting Official Training

Director Peele informed the Board that Early Voting Official Training will take place on Thursday February 8th and Friday, February 9th at 10:00 am. Both training sessions will be at the Board of Elections Office.

SBOE Winter Conference

Director Peele reminded the Board that the SBOE Winter Conference in Concord is February 4th-February 6th.

EAC Clearinghouse Community

Director Peele informed the Board that she has been invited to join the Elections Assistance Commission Community. Director Peele explained that the Clearinghouse Community is for elections officials from across the United States to communicate and share best practices and resources.
